- Avoid market noise and use temperamental advantage.

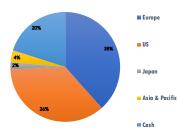

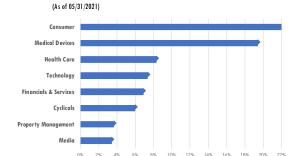

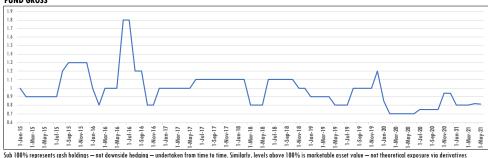
